RE: Right to Know Law Request

Dear Rep. Lawrence:

This firm is counsel to the Receiver for the City of Chester. I am writing in response to your request under the Pennsylvania Right to Know Law ("RTKL"), 65 P.S. §§ 67.101 *et seq.* A copy of your request is attached. Your request was emailed to the Office of the Receiver at 2:07 p.m. on Thursday, April 20, 2023. On April 26, 2023, this firm sent you a letter invoking the statutorily permitted 30-day extension to respond to your request.

Upon further review, your request is denied for the reasons set forth below, and as explained in the letter and affidavit of the Receiver attached hereto.

Denial Reason 1 – Records Do Not Exist, RTKL, 65 P.S. § 67.705

Your request is denied because the records you are seeking do not currently exist as you requested or because the agency does not currently compile, maintain, format, or organize the record in the manner requested. RTKL, 65 P.S. § 67.705, Creation of Record states, "When responding to a request for access, an agency shall not be required to create a record which does not currently exist or to compile,

maintain, format or organize a record in a manner in which the agency does not currently compile, maintain, format or organize the record."

SPECIFIC RESPONSES TO EACH REQUEST IS AS FOLLOWS:

Request: Copies of the "two credible plans" provided by Chester Mayor Kirkland to Receiver Michael Doweary as referenced in the April 17, 2023 DV Journal Article Entitled "Receiver: Chester's Dire Financial Straits May Lead to Disincorporation."

RESPONSE: Your request is denied pursuant to denial reason no. 1. Specifically, your request is denied because you are requesting records that do not exist.
